From 20th Century Studios and Matthew Vaughn prequel The King's Man is set to be released in February 2021 - starring Ralph Fiennes, Gemma Arterton, Rhys Ifans, Matthew Goode, Tom Hollander, Harris Dickinson and Daniel Brühl, with Diimon Hounsou and Charles Dance. Although there isn't much more details regarding the 1919 agricultural year, this was surely a very good year, given the high quality shown by this wine. During the last 100 years, this wine aged in 500 liters of used oak barrels in José Maria da Fonseca's cellar Adega dos Teares Velhos, in Azeitão. Now, the company has decided to fill 500 bottles of this brilliant wine to share with the world.

The early 20th century was a time of fast, intriguing changes: moving from decadent monarchies to new republics, revolutions, wars and an enlightened rationalism. Habits changed as the world was changing. But it is precisely the steadiness that comes from longstanding traditions of winemaking at José Maria da Fonseca that makes this exclusive limited edition of the 101year-old Moscatel Kingsman Century Edition 1919 such a rare opportunity. This outstanding wine has outlived its time, and will outlive us as history keeps changing.
